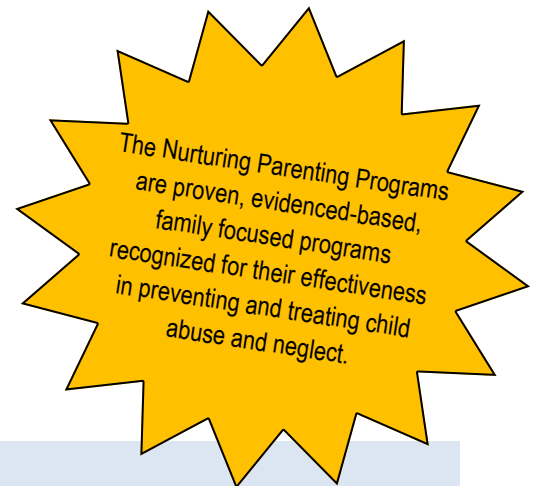
NP for Families in Substance Abuse Treatment and Recovery Training

The two day training will focus on:

- The impact of substance use, mental illness and trauma on parenting and the parent-child relationship
- The parent and their challenges of parenting in the context of substance abuse treatment and recovery
- The relationship between parent and child so the family can heal together

Participants will also learn how to monitor the success of families through on-going process evaluation strategies designed to measure the attainment of parenting knowledge and skills.

Participants will experience hands on approach to implementing Home-Based and Group-Based program models for this curriculum. Also, participants will learn how to administer and score the online versions of the Adult-Adolescent Parenting Inventory (AAPI-2.1) and the Nurturing Skills Competency Scales (NSCS).
