
Dear Friends,





KIDS ON THE BLOCK Gives children and teachers the tools they need to recognize and report child abuse. Using life size puppets, our Bullies and School Safety program educates children on bullying, promotes sensitivity towards peers, strategies to make schools safer, and how to cope with bad situations.

Children Educated

17,180 children and **1,453** adults through **275** puppet show performances

100% of teachers surveyed found the program helpful for their students.

94% of children completing pre- and post-test increased in their knowledge of ways to recognize and report child abuse.



NURTURING PARENTING PROGRAMS Teaches parents to adapt their attitudes, beliefs and behaviors about parenting. Programs use family-based curricula that are proven to reduce child abuse and neglect, and improve healthy family functioning.

Families Communicate

336 individuals participated **5,527** hours of service

88% of parents demonstrated increased ability to support their child's developmental milestones.

89% of parents showed a reduction in risk for abuse, neglect and/or exploitation.



PARENT ENRICHMENT SERVICES Unique program that provides a comprehensive parenting assessment and then recommends and provides targeted intervention based on each family's needs. Clients are referred through Hamilton County Job and Family Services.

Resiliency Taught

213 families served through individual and group services.

100% of children showed a reduction in trauma symptoms.

86% of parents reported a decrease in their use of corporal punishment.



STEWARDS OF CHILDREN Evidence-based curriculum training designed to educate adults on ways to prevent, recognize and respond responsibly to child sexual abuse.

Adults Act

2,329 adults received evidence-based training

87% of individuals trained committed to implementing at least one action step to protect children.

75% of participants showed an increase in knowledge of child sexual abuse.



TRAINING Provides training and consultation for other professionals to share knowledge, increase skills and support the replication of services in other settings.

Capacity Increased

126 professionals trained in the Nurturing Philosophy and Trauma Informed Care.

97% of attendees felt their trainer(s) demonstrated knowledge of the training content.

2,000 hours of professional training provided both internal and external.



TREATMENT SERVICES Provides evidence based interventions for children and adults who experienced abuse as a child. Individual, family and group counseling services, along with wellness supports and holistic services, are provided by experts who specialize in trauma-informed care.

Victims Healed

546 individuals served **2,668** individual counseling sessions

100% of adults completing individual therapy reported a decrease in trauma symptoms.

84% of children completing individual counseling decreased their trauma symptoms.



VISITATION Provides an opportunity for children to visit with non-custodial parents in a safe, supervised setting, and build skills needed to enhance healthy family functioning. Clients are referred through Hamilton County Job and Family Services.

Relationships Renewed

11,992 supervised visitations brought together **2,418** children and parents

93% of clients feel the staff believed in them and their success.

63% of active clients demonstrated progress in one or more assessed areas.
